## Instructions for Potential Delegates

**Filing Opens:** Tuesday, February 20, 2024 at 9:00 a.m. CT

**Filing Closes:** Monday, March 4, 2024 at 5:00 p.m. CT

**Fee:** \$300 per filing

Delegate application forms will be available at the Republican Party of Arkansas and online at [www.arkansasgop.org](http://www.arkansasgop.org). Candidates for Delegate or Alternate must turn in their completed and notarized form on or before 5:00 p.m. Monday, March 4, 2024, along with \$300, payable to the Republican Party of Arkansas, to the State Party Headquarters by either certified mail or by hand-delivery.

Hand-delivery is recommended to ensure receipt and so that the accuracy of documents can be confirmed. It is strongly recommended that you hand-deliver the closer it is to March 4, 2024. Documents are mailed at your own risk. Completed qualifying documents must be delivered to the Republican Party of Arkansas by the provided deadlines. No extensions can be given.
